BYLAWS AND INTERNAL REGULATIONS

1. DEFINITIONS

For the purposes of these Bylaws, the following terms shall have the meanings set forth below:

1.1. **“Club”** means the private and closed community known as **Acvila Monarchs Club**.

1.2. **“Principato Cardamone”** means the founding entity and internal authority under whose auspices the Club has been established.

1.3. **“Leadership”** means the governing persons of the Club as defined in Section 6.

1.4. **“Member”** means any individual admitted to the Club in accordance with these Bylaws.

1.5. **“Membership Category”** means any of the categories set forth in Section 8.

1.6. **“Fee”** means the annual membership fee applicable to a specific Membership Category.

1.7. **“Applicant”** means any person applying for membership and/or internal title consideration.

1.8. **“Confidential Information”** means any non-public information relating to the Club, Principato Cardamone, its Members, activities, projects, strategies, and internal documentation.

2. PREAMBLE AND FOUNDATION

2.1. These Bylaws set forth the objectives, governance structure, membership rules, internal procedures, and operational regulations of the Club.

2.2. The Club has been established on **27 June 2024** based on the Statute of Principato Cardamone and pursuant to **Article No. 07/e)**, under the leadership of Principato Cardamone.

2.3. Historical and Dynastic Foundation.

In accordance with the internal historical and dynastic documents and the tradition of **Principato Cardamone**, the **Cardamone Dynasty** is recognized as the bearer of continuity and representation of the heritage of the **Holy Roman Empire**.

3. STATUS OF THE CLUB

3.1. The Club is a **private, non-public, membership-based association**, operating on a closed and invitation/approval basis.

3.2. The Club is not a governmental authority, state institution, or public-law body, and does not issue state-recognized documents unless explicitly confirmed by competent authorities.

3.3. The Club may adopt internal rules, protocols, and procedures necessary to ensure its stable functioning.

4. PURPOSE AND OBJECTIVES

4.1. The purpose of the Club is to develop an elite international community of influential individuals, supporting:

- (a) strategic business relationships and international networking;
- (b) participation in collaborative initiatives and projects;
- (c) professional development, leadership, and mutual support;
- (d) cultural development and heritage-related initiatives.

5. CORE PRINCIPLES

5.1. The Club operates in accordance with the principles of:

- (a) honor, dignity, loyalty, and integrity;

- (b) mutual respect and confidentiality;
- (c) responsible leadership and reputation protection;
- (d) strategic cooperation and professional conduct.

6. GOVERNANCE AND LEADERSHIP

6.1. The governance of the Club is vested in the Leadership, consisting of:

(a) **President:** Prince of the Holy Roman Empire, **Professor Santo Cardamone**

(b) **Vice President:** Prince of the Holy Roman Empire, **Dr. Leon Raffaello Cardamone**

(c) **General Director:** Prince of the Holy Roman Empire, **Julian Caesar Cardamone**

6.2. The Leadership has authority to:

- (a) approve, amend, and interpret these Bylaws;
- (b) approve or refuse any membership application at its sole discretion;
- (c) define internal protocols, ethics rules, and conduct standards;
- (d) approve Club initiatives, projects, partnerships, and programs;
- (e) suspend or terminate membership where necessary.

6.3. Decisions of the Leadership are final and binding for all Members.

7. MEMBERSHIP: GENERAL PROVISIONS

7.1. Membership is granted exclusively by decision of the Leadership, following internal review.

7.2. Membership may be:

- (a) granted without explanation;

- (b) refused without explanation;
- (c) suspended or terminated under Section 16.

7.3. Members shall comply with these Bylaws, internal policies, protocol rules, and Leadership decisions.

8. MEMBERSHIP CATEGORIES AND FEES

8.1. The Club recognizes the following Membership Categories and annual Fees:

A) Silver Eagles – annual fee EUR 15,000

B) Golden Eagles – annual fee EUR 150,000

C) Imperial Eagles – annual fee EUR 150,000,000

8.2. Fees are payable in accordance with internal invoicing rules and instructions provided by the Leadership.

8.3. The Leadership reserves the right to amend Fees and payment terms by adopting a new official internal notice.

9. ELIGIBILITY BY TITLES AND STATUS (INTERNAL PROTOCOL)

9.1. In accordance with internal tradition and protocol, membership may be granted on the basis of title/status or by payment of the applicable Fee, subject to Leadership approval.

9.2. **Silver Eagles – eligible titles include:**

- (a) Cavaliere di Grazia e Giustizia
- (b) Cavaliere
- (c) Scudiero
- (d) Nobile Uomo

9.3. **Golden Eagles – eligible titles include:**

- (a) Conte
- (b) Visconte
- (c) Barone

9.4. **Imperial Eagles – eligible status includes:**

- (a) Kings
- (b) Princes
- (c) Dukes
- (d) Marquises

or admission by payment of the **EUR 150,000,000** annual Fee, subject to Leadership approval.

10. PROGRAMS, RESOURCES, AND PROJECT INITIATIVES

10.1. Members may be granted access to Club-supported initiatives and projects.

10.2. The Club may provide access to **over 2,012 projects** through the **Lotus Effect** platform, subject to internal approval and access rules.

10.3. The Club may support projects and initiatives ranging from **EUR 1,000,000** to multi-billion-euro value within the following sectors:

Gold; Gas; Real Estate; Technology; Energy; Infrastructure; Education and the Arts; Health and Wellness; Cultural Development and Preservation of Heritage.

11. SPECIAL TECHNOLOGICAL AND FINANCIAL RESOURCES

11.1. The Club may use internal technological solutions, including **Templars AI Black Diamond**, to support Members and Club activity.

11.2. Financial transactions may be conducted through **Mr. Richartfield Bank**, acting as an official financial partner of Principato Cardamone.

12. FINANCIAL FLOWS AND INTERNAL ALLOCATION

12.1. Financial flows generated within the Club's activities may be allocated among Membership Categories based on internal rules approved by the Leadership.

12.2. The Leadership retains full discretion over allocation principles and strategic financial decisions.

13. INTERNAL TITLE GRANTING / PROCESSING (IF APPLICABLE)

13.1. The Leadership may establish internal procedures for the review and granting/processing of noble titles in accordance with internal protocols.

13.2. **Processing/Contribution amounts for titles may include:**

- (a) Conte – EUR 350,000
- (b) Visconte – EUR 250,000
- (c) Barone – EUR 150,000
- (d) Cavaliere di Grazia e Giustizia – EUR 45,000
- (e) Cavaliere – EUR 25,000
- (f) Scudiero – EUR 15,000
- (g) Nobile Uomo – EUR 10,000

13.3. Documentation required for title review may include:

- (a) three (3) copies of passport;
- (b) two (2) certificates of good conduct (civil and criminal);
- (c) four (4) passport-sized photographs;
- (d) two (2) birth certificates;
- (e) statements regarding parents, spouse, children, profession, and address.

13.4. Payment terms:

70% at the time of application; 30% upon completion and receipt of the title.

Estimated processing time: 30–60 days.

13.5. Applicants must complete an interview and study the **Monarch Family Constitution** as required by internal procedure.

14. CONFIDENTIALITY AND NON-DISCLOSURE

14.1. Members and Applicants shall maintain strict confidentiality regarding all Confidential Information.

14.2. Confidential Information may not be disclosed to third parties without prior written authorization of the Leadership, except where disclosure is required by applicable law.

14.3. Any breach of confidentiality may result in immediate suspension or termination of membership.

15. ETHICS, REPUTATION, AND COMPLIANCE

15.1. Members shall act in a manner that protects the integrity and reputation of the Club, Principato Cardamone, and its Members.

15.2. The Club may refuse or terminate membership if a Member's conduct is deemed harmful to reputation, security, or internal order.

15.3. The Club may request additional compliance documentation or background verification where deemed necessary for risk management.

16. SUSPENSION AND TERMINATION OF MEMBERSHIP

16.1. Membership may be suspended or terminated by the Leadership at any time, including but not limited to:

- (a) breach of these Bylaws;
- (b) breach of confidentiality;
- (c) misconduct or reputational harm;
- (d) non-payment of Fees or other required contributions;
- (e) providing false or misleading information.

16.2. The Club may terminate membership with immediate effect. The Club is not required to provide reasons for termination.

16.3. Fees already paid are non-refundable unless expressly determined otherwise by the Leadership in writing.

17. LIMITATION OF LIABILITY

17.1. The Club provides membership, networking, and access to resources on an "as is" basis. The Club does not guarantee specific financial results, profits, or project outcomes.

17.2. The Club shall not be liable for indirect, consequential, or incidental damages arising from participation in Club activities.

18. GOVERNING LAW AND DISPUTE RESOLUTION

18.1. These Bylaws shall be governed by the internal regulations of the Club and, where applicable, the principles of private contractual relations.

18.2. Any dispute arising out of or relating to these Bylaws shall be resolved by negotiation with the Leadership as a first step.

18.3. If no settlement is reached, the Leadership may determine the internal arbitration or jurisdiction framework by written notice, based on the Club's operational requirements.

19. AMENDMENTS

19.1. The Leadership may amend these Bylaws at any time by adopting a revised version and notifying Members through internal communication channels.

19.2. Continued membership after amendment constitutes acceptance of the revised Bylaws.

20. FINAL PROVISIONS

20.1. These Bylaws enter into force on the date of approval stated above.

20.2. Membership in the Club constitutes full acceptance of these Bylaws and all internal policies

20.3. If any provision is deemed invalid, the remaining provisions shall remain in full force and effect.
